Public procurement accounts for a substantial portion of government expenditures. According to Procurement Tactics, public procurement represents approximately 10 to 15 percent of a country's Gross Domestic Product, with the U.S. spending approximately \$1.8 trillion in 2020. - **Measure Supplier Performance:** Assess supplier reliability and quality to identify and prioritize effective, efficient vendors when available (and avoid poor performers).
- **Optimize Procurement Processes:** Use data to detect inefficiencies and areas for improvement in the procurement lifecycle.

With better insight into project effectiveness, vendor and supplier performance, and historical cost spend, agencies can significantly improve the requisition and solicitation process, budget better, and provide more taxpayer value.

The **City of San Diego** overcame complex and time-consuming manual processes for faster bid evaluations and centralized vendor management, processing 64 Requests for Pricing, 54 Invitations to Bid, 7 Requests for Quote, and 1 Request for Statement of Qualifications in 2024.

Additionally, continuous upskilling by investing in career training and development ensures that your team is equipped with the necessary skills and knowledge to budget, strategize, plan, and purchase more efficiently.
